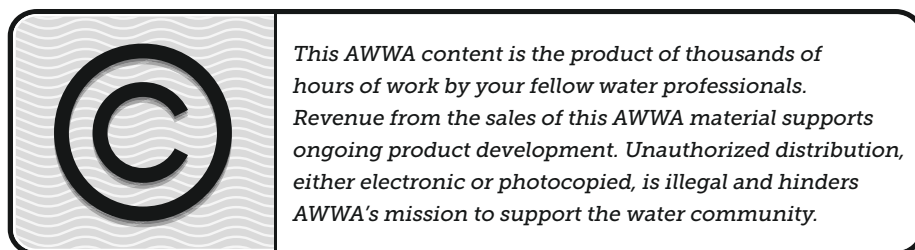
AWWA Standard
