This standard differs from DIN EN ISO 20345:2007-12 as follows:

- a) normative references have been updated;

- d) in Subclauses 3.14 and 3.15, a reference to the test in accordance with ISO 20344 has been included;
- e) Subclause 3.19 "Hybrid footwear" has been included;
- f) in Clause 4, a reference to other materials and requirements in accordance with the new Annex A "Hybrid footwear" has been included;
- g) slip resistance requirements have been moved from Annex A to Clause 5;
- h) in 5.3.2 "Toe protection" a reference to EN 12568:2010 has been included;
- i) requirements for the thickness of outsoles and the cleat height have been added;
- j) requirements relating to 5.8.4 "Flexing resistance" or spontaneous cracks have been added;
- k) in 6.2.2.3, a reference to EN 50321 has been included;
- I) in Clause 7, marking categories of safety hybrid footwear have been included;
- m) a new Annex A "Hybrid footwear" has been included;
- n) the requirements for the information to be supplied regarding electrically insulation footwear have been deleted
